Speech-Language Pathologist (part-time): The Speech-Language Pathologist will use a wide range of test materials and assessment procedures in areas of speech, language, voice, fluency and hearing and maintain familiarity with improved methods and material as well as use of varying technique for remediation in the areas of speech, language, voice, fluency and hearing. It will be the responsibility of the SLP to develop appropriate long-range IEP goals for students commensurate with their individual needs and implement appropriate clinical procedures in providing individualized programming to each student. The SLP will be responsible for providing consultation and/or materials to parents, teachers and others as appropriate regarding individual students and/or speech, language, voice, fluency and hearing disorders and developing clinical management plans which are easily followed, comprehensive and consistent with clinical objectives, including the maintenance of clinical data for each student. The SLP will be a part of the Student Study Team and participate in staffings, as appropriate, and the placement process for the school's speech-language program. It is the responsibility of the SLP to ensure that all speech-language-hearing information required for ESSS decision-making purposes is available and reviewed. The SLP will also fulfill required FTE record-keeping responsibilities accurately and punctually and communicate with students' parents in regard to legal rights and informed consent.

Qualifications: Master's Degree in speech language pathology or communicative disorders and Florida Department of Education Certification or Florida licensure in speech-language pathology under the Department of Professional Regulations, knowledge of Federal, State and Local laws and policies as they pertain to speech-language pathology and knowledge of computer applications and applicable clinical technology as related to specific job functions.
