With the approval of the directors present, Debbie Hahs-Vaughn and Javier Rivera acted as Chair of the meeting, and Debbie Hahs-Vaughn recorded the minutes.

On motions duly made and seconded, it was voted that the minutes of the meeting of board of directors from July 16, 2019 and July 8, 2019 to be taken as read.

#### II. Celebrations/Recognitions

a. School grade. The annual learning gains were wonderful this year. We made significant progress with our high performing learners, who showed great growth. Galileo maintains its designation as high performing charter school.

#### III. Informational Items

- a. Check status of new board members' board training. Mrs. Marshall has submitted paperwork and is waiting to be contacted to do training.

#### ٧. Principal Report (M. Nunez)

- a. One month from the gala. Advertising begins tomorrow. The Commissioner of Education, Richard Corcoran, is attending.
- b. The school year is going very smoothly.
- c. OurDeputy will be leaving September 2, retiring from the sheriff's office. Another Deputy will be joining Galileo, and he has a therapy dog. He should be joining on or before the current Deputy retires.
- d. The CSP grant, \$525K towards the new building. Per Florida DOE, we have to resign this grant and reapply for a new one since we are not ready to open the school. According to the DOE, because the opening of our campus was delayed, it is beyond the RFP for the federal government funding window. Although we reported the delay in 2018, the DOE just noted that the funding of this grant will not comply with the new opening date. There will be a special competition opened for Galileo and another school in the same situation, per the DOE. Implementation cannot begin until the school is open, per Florida DOE.
- e. A proposed 2019-2020 budget was reviewed. Mrs. Nunez recommends adding \$100K to savings now and another \$50K in January from the 2018-19 school year Motion made, second, all approved to approve the proposed budget.
- f. Motion to keep no more than \$250K for all accounts other than operating accounts at any one financial institution. At that point, the principal shall report that to the board. Mr. Miller will work with Mrs. Nunez on suggestions for other institutions.

### VI. **Committee Reports**

- a. Standing Committee Reports
  - i. Budget and Finance Committee (MacLaren)
    - 1. Financial statements were reviewed. For fiscal year, Galileo ended with a surplus of approximately \$153K. The audit was excellent. There were no material weaknesses reported. The one suggestion was to move funds so that more than \$250K is not in one account. Motion made, second, all approved to approve June financials.

- ii. Curriculum Committee (M. Gill). No report.
- iii. Development & Grants (T. Marshall)
  - 1. Update on Fall 2019 gala. The goal is to net \$20K. Presently, have \$10.5K in sponsorship. Auction donations are going well. There are several tentative donations. Several celebrities are lined up, including the commissioner of education and several television personalities.
- iv. Marketing (C. Edwards). No report.

PTA/SAC Updates. No updates. SAC meets next week.

- b. Special Committee Reports
  - i. Facility Committee (K. Miller)
    - 1. The property adjacent to Galileo that will be used for the parking lot is under contract. The facilities committee recommends putting \$100K down and financing the rest.
    - 2. Update on second school facility. The builder indicates that we are still on target for opening Fall 2020. The county has our plans and has 60 days to comment. Breaking ground by October is needed per Little's schedule.
    - 3. September 4 is the planning and zoning meeting to consider zoning for the kindergarten at the new school. The full board meeting is September 10.
    - 4. A decent amount of repairs were made during the summer to the current building. About ½ of the windows that need to be replaced have been replaced. The good news is that there is no leaking.
  - ii. Strategic Planning Committee (R. Margadonna). The report was sent to the Board and discussed at last meeting.
