On motions duly made and seconded, it was voted that the minutes of the meeting of board of directors from November 1, 2021 to be taken as read.

- The employee town hall was held. Comments were shared from staff attending. The I. Board expressed their great appreciation for all the Galileo teachers and staff.

- ٧. Principal Report (M. Nunez)
 - a. Skyway building update. The SCPS Deputy Superintendents visited today and were impressed with the new facility. The facilities committee will be conducting a walk through to determine what still needs to be completed.
 - b. PTA/PTO. PTAs from Skyway and Riverbend are not in alignment with governmental structure. Skyway will continue with a PTSA and Riverbend will move to a PTO.
 - c. Enrollment. Middle school enrollment in 7th grade is an area of deficit. Tours will begin in January, and the lottery opens in January.
 - d. Maternity leaves upcoming for Spring 2022: Bookkeeper, Behavior Specialist, School Psychologist, Staffing Specialist, Teacher.
 - e. PPP Loan update. Began making payments on the remainder of the loan (total was approximately \$52K), and this should be paid off by the end of this calendar year.
 - f. CSP Grant update. The remaining funds will be spent on a shade that will cover the Skyway basketball court.
 - g. American Rescue Plan ESSER III dollars. This recent pot of money that can be used to address needs that occurred as a result of the pandemic will be spent on additional staffing and portables to create more space between students.

 - iv. Update on Silent Auction. The silent auction was a great success! Total income was \$13,841; after expenses, netted slightly more than \$11K. This was more than anticipated the school would receive. The software to manage was a great resource for data mining, and the school have access for 18 months.

Lisa Bengel and Mr. Briggs are working together on a proposal. Mrs. Nunez will follow up with Mrs. Bengel. Motion made, second, all approved to authorize Mr. Briggs' to file for ERTC funding up to a fee of 7%.
- XI. Review of current legal counsel (D. Hahs-Vaughn). Suzanne D'Agresti has retired. Kevin Miller will work with Mrs. Nunez on a recommendation for a new attorney.
- XII. Input on potential new website. The school received a \$10K anonymous gift to rebuild the website. The marketing committee is supportive of using Square Space. Motion made, second, all approved to spend up to \$3,800 for photography and video footage for the new website. The Board recommends exploring the option of using parents who are professional photographers if possible.
