The Galileo VPK program is underway and going well. They are using the Creative Curriculum. Two different math curriculums are being used between the two campuses. At the end of the year, administration will look at proficiency data to see if one curriculum seems to have been more successful than the other. There were discussions about working with diverse populations.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GALILEO SCHOOL FOUNDATION, INC. ADOPTED AT A MEETING OF THE BOARD HELD ON JANUARY 20, 2021.

WHEREAS, The Galileo School Foundation, Inc., a Florida not-for-profit corporation and an organization described in Section 501(c)(3) of the Internal Revenue Code (the "Corporation") is expected to incur certain costs in relation to the proposed acquisition of Riverbend and, possibly, Skyway Galileo School for Gifted Learning Charter School Facilities from Cameron Avenue Charter Property, LLC and Building Hope Skyway Drive, LLC, respectively, the current owners and lessors of such Facilities, and the acquisition and construction of various capital improvements to such Facilities, as necessary (collectively, the "Schools");

WHEREAS, the Corporation has determined it is in its best interest to request a qualified issuer (the "Issuer") of tax-exempt obligations to issue such obligations on its behalf in order to finance and refinance all or a portion of the costs of such Schools and to reimburse itself for costs of such Schools incurred by the Corporation prior to the date of issuance of such tax-exempt obligations; and

WHEREAS, the United States Department of Treasury has issued various regulations in regard to reimbursement of prior expenditures with the proceeds of tax exempt debt;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE GALILEO SCHOOL FOUNDATION, INC. AS FOLLOWS:

SECTION 1. It is the intent of the Corporation to reimburse various costs and expenditures relating to the acquisition and construction of the Schools including, without limitation, those listed in Exhibit A hereto, all of which costs and expenditures represent "original expenditures" as such term is defined in Treasury Regulations Section 1.150-2(c). Such original expenditures are expected to be paid from the Corporation's charter revenues generated from the ownership and operation of the Schools and other miscellaneous revenues of the Corporation. It is reasonably expected that reimbursement of such original expenditures shall come from the issuance by an Issuer of tax-exempt debt which is not expected to exceed \$30,000,000 aggregate principal amount. It is currently the intention of the Corporation to secure such tax-exempt debt by a pledge of and lien upon the operating revenues of the Corporation including the charter revenues derived from the operation of the Schools. The expenditures to be reimbursed shall be consistent with the Corporation's budgetary and financial policy as being the type of expenditures which shall be paid on a long-term basis.

SECTION 2. It is the intent of this resolution to meet the requirements of Treasury Regulations Section 1.150-2 and to be a declaration of official intent under such Section.

SECTION 3. This resolution shall take effect immediately.
