On motions duly made and seconded, it was voted that the minutes of the meeting of board of directors from September 27, 2021 to be taken as read.

- I. Celebrations/Recognitions

 - ii. Review of quarterly budget. Ran deficits at both schools in August but rebounded somewhat in September. Still running a deficit at both schools, but this narrows the deficit at both. Appears to be on track with the budget at this early point in the new fiscal year. Motion made, second, all in favor to accept the treasurer's report.

- VII. Caleb Edwards eligible for Board reappointment. Motion made, second, all in favor to reappoint Caleb Edwards to the Board.
- VIII. Treva Marshall eligible for board reappointment. Motion made, second, all in favor to reappoint Treva Marshall to the Board.
- IX. Employee Retention Tax Credit (ERTC) funding proposal. This is funding similar to PPP funding but in the form of a cash credit. Mr. Karsten Briggs shared information on this. ERTC is strictly for personnel funds for Q2 2020 through Q4. One way to qualify is governmental action that limits operations. The way that credits work, whatever is forgiven by PPP, they cannot double dip so cannot overlap with PPP. For 2020, it's a max of \$5,000 per employee per year. The application would be applying in arrears. The rebate given back to the school counts as miscellaneous income so the school

would have to pay taxes on it. The program ends 12/31. The fee is 7% of what is received by the school. If the school does not receive funding, Mr. Briggs' company does not receive funding. Mr. Briggs will present at the December Board meeting.
