#### VI. Principal Report (M. Nunez)

- a. Daycare update. Due diligence is being finalized and will be submitted to the county after their meeting with Galileo this week.
- b. Enrollment update. Both campuses have a little movement, but the waiting list is still strong.
- c. Staffing update. The mental health counselor recently resigned, and this is the only position available right now. A principal intern will begin in the Spring, working on the Skyway campus with Mrs. Nunez. One of Dr. Gill's doctoral students is completing a case study of Galileo.

#### VIII. **Committee Reports**

- Standing Committee Reports
  - i. Budget and Finance Committee (J. MacLaren). When reviewing both campuses, there is a \$60K surplus. A brokerage account is being set up to move savings to higher yield accounts and to diversify to ensure they are FDIC insured. Motion made, second, all in favor to approve the monthly financials.

- ii. Curriculum Committee (M. Gill)
  - iii. Report from November meeting was shared via meeting minutes. Mrs. Nunez shared an update. The primary focus of the meeting was to discuss the Reggio Emilia model. A group of teachers and administrators will look at if/how parts of the model can be incorporated into the preschool and other grades.
  - iv. Requesting to add Jana Spitalnick as a member of the curriculum committee to replace Clary Kirts, who is now a consultant at Galileo. Motion made, second, all in favor to add Jana Spitalnick to the curriculum committee.
- v. Development & Grants (T. Marshall). The new campaign had a soft launch. Mrs. Marshall suggests that we introduce a challenge grant to the school community, with the Board matching up to \$10,000. Galileo has applied for funding for appropriation from the state, specifically \$500K towards the early learning center.
- vi. Marketing (D. Hahs-Vaughn). No updates.
- Special Committee Reports
- vii. Facility Committee (J. Wilkes). Four classrooms took on water during the storms before Thanksgiving, three of which had to have remediation. A building consultant reviewed the school to provide recommendations.
- viii. Two quotes were secured for HVAC. Motion made, second, all in favor to approve the HVAC repair from ABM.
- ix. Strategic Planning Committee (J. Rivera)
  - x. Review and vote on Strategic Planning Committee recommendations
- IX. PTSA/SAC Updates. Both campuses are working on literacy related projects. Riverbend is putting in a book vending machine. Skyway is adding a little community library for families to exchange books as they do in many neighborhoods.
